









## Forum for victims of systemic crimes in Africa

## 13-14 April 2012, Banjul, The Gambia

#### Background

The Institute for Human Rights and Development in Africa (IHRDA), the Cairo Institute for Human Rights Studies (CIHRS), the Independent Medical- Legal Unit (IMLU), REDRESS and the Victims Rights Working Group (VRWG) will organise a 1.5 days regional meeting on victims and justice processes in Africa in the margin of the NGO Forum/ the 51<sup>st</sup> Ordinary Session of the African Commission on Human and Peoples' Rights in April 2012. The main focus of the meeting is to bring together approximately 15-20 experts/ representatives of civil society from African countries to discuss and exchange on experiences of victims of systemic crimes in accessing justice at the national, (sub-) regional and international levels.

The meeting will provide a platform for lawyers, activists and others to exchange on experiences made and discuss strategies for the way forward. We expect that the meeting also serves as an opportunity for networking with a view to establishing a network of national and international civil society groups and experts to ensure that victims' rights are effectively protected at the national, regional and international levels.
